The Committee on Annuities and Investments wishes to submit the following report:

On March 30, 2022, the Department of Retirement Services issued a statement on its website regarding the discovery of financial irregularities concerning the retirement fund. The statement indicated that the AME Church had secured legal counsel as well as financial forensics experts to assist in the investigation and that the organization was also working diligently with federal authorities to determine the appropriate course of action.

To address additional concerns, the statement included a list of frequently asked questions along with explanations pertaining to process, procedure and the current status of the fund as of that date.

In October of 2022, participants in the AME Church Retirement Fund received an update in the form of a letter which stated that the General Board of the AME Church had voted in favor of partnering with Wespath Benefits and Investments to develop and to become the plan administrator of a new retirement plan. Wespath's experience and credentials were noted, and participants were advised to contact the Department of Retirement Services for further information.

The official launch of the New Life Personal Investment plan occurred in November 2022. Participants were strongly encouraged to engage in educational and discussion sessions with Wespath that were sponsored by the 7<sup>th</sup> Episcopal District and Bishop Green via zoom.

In March 2023, the Department of Retirement Services issued another letter to all of the participants in the retirement plan. It stated that a formal report regarding the status of operations and procedures would be presented at the June 2023 General Board meeting. Participants were made aware of several ongoing activities such as pending litigation, possible resolutions, the Legacy Plan, audits, financial reviews, and web-based accounting that would allow participants to verify all transactions and balances through their own secure online accounts.

#### **Recommendations:**

- 1-Participants continue to be diligent in reading any correspondence received from the Department of Retirement Services of the AME Church.
- 2-Participants should keep abreast of any new developments regarding the retirement plan, past and present.
- 3-Participants to become knowledgeable and informed about every aspect of the Wespath Benefits and Investment group, taking advantage of any opportunities that may be offered through the program.
- 4-Participants access their online accounts as frequently as possible to ensure accuracy of contributions.

**Report:** The 2021, Book of Discipline of the African Methodist Episcopal Church, requires that all Pastors be classified in class designations A-E. The classifications are defined as follows:

Class A: Full time pastors having traveled eight consecutive years; and any ordained Elder holding a degree from a college or seminary and shall have traveled at least one year as a fulltime pastor. Full time pastors are Itinerant Elders who wholly and solely give of their time and talents to pastoral duties without any other work, professional or common, interferes with or prevents the performance of the regular ministerial duties of a pastor as negotiated between the pastor and the Board of Stewards.

**Class B**: Itinerant Elders having traveled four consecutive years as a full-time pastor.

**Class C**: Full-time pastors who are Itinerant Elders in the AME Church.

*Class D*: Full-time pastors who have not been ordained itinerant elders.

The newest initiative in the South Carolina Conference is the Cane Bay Fellowship, in the Charleston District, where Rev. Allen W. Parrott is the Presiding Elder. Rev. Tremayne Bowman is the founding pastor and currently Licentiates Jeffrey and Leslie Graham serve as the supply co-pastors. The motto of this fellowship is "The church without walls." It is an important example of post pandemic worship. Social media including Facebook is used to conduct worship and Bible Studies and to keep the congregation informed. Because of this unique platform, sermon engagements by the supply co-pastors are also shared via social media. Cane Bay Fellowship has partnered with Mt Zion AME Church, 5 Glebe Street, Charleston, SC, where Rev. Dr. Kylon Middleton serves as pastor. Mt Zion's weekly Bible Studies are a prominent ministry of the Cane Bay Fellowship.

This new initiative serves as a paradigm for establishing new congregations in the post pandemic world. Here are a few of its strengths.

First, Cane Bay is located in Dorchester County and is one of the fastest growing communities in the state. More importantly, it is expected to continue to grow for the foreseeable future.

Second, the Cane Bay Fellowship has taken advantage of social media and modern technology. Consistent with its motto, this fellowship is truly a church without walls.

Third, senior leaders have partnered with junior leaders to take advantage of their unique generational knowledge and skill sets.

#### Report:

Economic depravity, human trafficking, political corruption, police brutality, global warming, high suicide rates among clergy and a steady membership decline among mainline denominations are just some of the rising issues that our Zion faces daily. In this new era of cultural challenges, one must ask a vital question how can we lead God's people to spaces of flourishing transformation in times of crisis and moments of increased complexity? Simply over the last 12 to 15 months the church has chosen to use its various distresses as purposeful challenges to rediscover its foundational mission through recalibration, re-structuring, and rebirth.

Recalibration calls us to visualize the church's mission from its initial stages in comparison to our present realities. Today our mission as the church of Allen is to minister to the social, spiritual, and physical development of all people. Initially this divine assignment was set to expand Gods liberation to those bound in slavery, bring justice to marginalized persons that were denied basic human rights in all areas of their lives and build a church welcoming for all of Gods children.

As time progressed the church has realized that our ancestors' unresolved issues from the past currently have been given new faces and spaces, striving every day to trade a more progressive society for negatively retroactive cognitive social behaviors. The church has strategically used value-based conversations, in order to bring resolve to some of our key issues with educated practitioners in their respective fields. Value based conversations allowed our church to see that our mission was still needed but our priorities needed to be adjusted. This can be seen in our Zions print and digital media through the Christian Recorder and virtual TCR dialogues where no topic yet remains to be off limits to show the world the authentic significance of creative engagement with Christ beloved communities with relevancy, transparency, accountability, consistency, and sustainability.

Re-structuring develops the church's vital conversations into an action plan that's keeps our vision in full visibility and viability. This process helps everyone strengthen what remains instead of focusing on what has been lost in the past. Our church has used various tools that drive the heart of operational change in every local congregation within our Zion. In September of 2002, the African Methodist Episcopal Church (AMEC) initiated the Strategic Church Planning a two-year effort to develop a vibrant, growing denomination that accomplishes the Great Commission that is currently being implemented today. To keep our church thriving, healthy, and full of life we have initiated creative membership drives where everyone can reach the masses through evangelism. Vibrantly stronger churches have rapidly increased youth and young adult programming has with a flair of excitement due to the rising attendance of millennials and gen z in worship services.

According to the Barna group since 2019, the percentage of Millennials reporting weekly church attendance has increased from 21 percent to 39 percent. Among Gen X, attendance has increased 8 percentage points (24% to 32%). Also the church remains to be steadfast in its march towards racial justice, equity, and freedom instead of taking a backseat to daily injustices happening in the lives of African Americans. It has been documented by the Barna group that based upon recent data from June 4-15, 2020 show that just three out of five pastors (62%) said their church denomination made a statement on the recent protest happening across the nation; with a belief that the Church has a responsibility to publicly denounce racial discrimination and publicly show support for people of color.

Purposeful rebirthing ensures the church lives up to its mission through its work that is led by extraordinary servant leadership of clergy and laity. Rebirthing gives new light for the world to see a unified body of believers that constantly strives to enhance church growth, constitute a delegated body that is representative of our diverse membership, support Christian character, and enhance spiritual growth & development. The church overall manifests a clean start that chooses to embrace and instill in the membership of the Church, history, traditions, and principles of African Methodism, while being open to the changes and challenges of contemporary society.

Greetings to Bishop Green, Supervisor Green, Presiding Elders and the members of the 160<sup>th</sup> Session of the South Carolina Annual Conference, we, the (Committee name), beg leave to make this report:

#### Report:

The Apostle Paul quotes nine specific traits that are found in Galatians 5: 22-23. They are identified as the "fruit of the Spirit', that is the results of the Holy Spirit operating in a Christian's life. The scripture text states, "But the fruit of the Spirit is love, joy, peace, longsuffering, gentleness, goodness, faith, meekness, temperance: against such there is no law." This list describes what those in Christ should see flowing from their lives when they are engulfed by the Holy Spirit. In this report temperance will be our focus. Temperance is defined as moderation in thought, word, or action. Those who practice temperance are self-controlled and show restraint in their passions and behaviors. Another word that often defines temperance is self-control. Temperance or self-control plays a vital role in our daily conduct and can be anything from gluttony to gambling. The Holy Bible includes numerous scriptures regarding temperance, a few examples are Titus 2:12, 1st Corinthians 9:27, 2 Peter 1:5-6, Proverbs25:28, Philippians 4:5, 1 Timothy 3:8-9, and Proverbs 20:1. In order to put our faith into action, we need the Holy Spirit to help us live a life of temperance. This life is demonstrated by self-control, self-discipline, moderation, and restraint if we are to live a victorious Christian life. We are living in unprecedented times and the current situation, finds us in a predicament to navigate through what is deemed as our "new normal." We will address four areas that are very pressing issues that we believe are pertinent to our focus on temperance. If we are to achieve positive outcomes these should be our focus.

1) Black on Black Violence- Our communities are experiencing increased numbers of black on black, crime and deaths. Senseless deaths are occurring because those involved appear to think that using a gun to solve disagreements is necessary instead of using conflict resolutions to resolve the matter. Some of our people seem to have no regard for taking a human being's life and the consequences of their actions. We need to educate our people and let them know that self-control and self-discipline are vital in all aspects of life. We also need to focus on the village of the family and community to help prevent the negative conditions that draw our people into violent and criminal behaviors.

- 2) Social Justice- We continue to be the victims of senseless murders by the hands of police officers, who have been sworn to protect us, because of the color of our skin. Some of the victims for 2022 are: Patrick Lyoya- April 4, 2022, Grand Rapids, Michigan, Christopher Kelley June 24,2022, Topeka, Kansas, Donnell Rochester, 18, February 19, 2022, Baltimore, Maryland, Amir Locke,22, Minneapolis. Minnesota, Isaiah Tyree Williams, 19, Las Vegas, Nevada, January 10, 2022, and Jason Walker, 37, Fayetteville, North Carolina, January 8, 2022, just to site a few. Our struggle against America's century long legacy of institutionalized racism continues daily. We are working together, uniting our voices, and taking various social actions including peaceful protests intended to initiate change. Voting in upcoming elections is pertinent to our success.
- 3) COVID 19 Endemic- COVID- 19 continues to ravage our communities at alarming rates. Statistics show that worldwide we have a total of 199,673,017 cases and 4,249,118 deaths. In the United States of America there are 35,325,243 cases and over a million deaths as of July 28, 2022. In the state of South Carolina there have been 1,573,585 cases and over 18, 055 deaths. There are three vaccines that are presently available to combat the virus. They are Pfizer, Johnson, and Johnson and Moderna. They are all authorized by the FDA and recommended by the CDC to be used in the US for a limited population. As of July 28, 2022, 59.34 percent of the people in the United States of America are fully vaccinated. In South Carolina only about 20 percent of the African Americans are fully vaccinated. There same to be many myths that are negatively affecting the rate of the vaccines. The best way to prevent the illness or contracting the disease is to avoid being exposed to the virus and taking the vaccines, and boosters. Temperance and self-discipline are needed for such a time as these. The Centers for Disease Control have established strict guidelines that everyone needs to adhere to, to limit the spread of this deadly disease. Get vaccinated, it can help save your life.
- 4) **Alcoholism** Another issue that we are presently engaged in is the war on Alcoholism. In a recent publication produced by the National Institute on Alcohol Abuse and Alcoholism, Alcohol Use Disorder (AUD) in the US follows: 14.4 million adults age17 and older have an AUD. This includes 9.2 million men and 5.3 million women. The same study looked at youth ages 12 to 17. An estimated 401,000 adolescents ages 12-17 have AUD. This number includes 173,000 males and 227,000 females. Alcohol related deaths total 88,000 persons and 1 person dies every 50 minutes in drunk driving fatalities in the US. For these reasons and more, temperance is needed to limit alcohol consumption. Recent data indicated that alcohol consumption has increased with the advent of COVID 19.

#### **Our Recommendations include:**

- 1) Black on Black Violence Churches are encouraged to identify Christian Apps to share with their youth and adults on God's love, conflict resolution, and anger management. Bible studies on Christian tenets and scriptures relative to demonstrating self-control in one's behavior should be considered and is recommended.
- 2) Social Action/Justice The church should encourage all congregants and members of the local community to vote. Use of AME Voter Alert Toolkit to help register, educate, and organize, etc. is recommended.
- 3) The Corona Virus Pandemic/Endemic -We encourage all churches to use online group calls, digital and virtual media options to reach their congregations with prevention messages to adhere to CDC guidelines. We also encourage churches to become sites for testing and vaccine sites to cut down on the spread of the virus. We should also encourage all eligible individuals to get vaccinated. Vaccines have been implemented for centuries and has assisted in the control and spread of diseases.
- 4) Alcoholism—We encourage all churches to prepare a directory of information for support groups or counselors and recovery programs that are available to help anyone in need. Also conduct a Bible Study series on Temperance using virtual webinars and or any other avenues that may be suitable to help eliminate this addiction.

To enhance communication, the official SCCB WMS Newsletter, Mission Matters, was utilized to disseminate pertinent details, updates, and announcements. ## DISASTER PREPAREDNESS

#### **Salutations:**

Greetings to Bishop Green, Supervisor Green, Presiding Elders, and the members of the 160<sup>th</sup> Session of the South Carolina Annual Conference. We, the Disaster Preparedness, beg leave to make this report:

#### Report:

What is a Disaster?

Disasters can have varying scopes and causes, ranging from those caused by human actions to those triggered by natural events. These can include floods, hurricanes, tornadoes, earthquakes, and epidemics. It's important to remember the impact of disasters can result in positive and negative changes for affected communities. Each congregation must take the time to understand the potential risks their congregation may face and plan accordingly.

The impact of any event depends not only on the cause of the crisis but also on the environment in which the crisis comes. Many variables affect the community's ability to return quickly to everyday life: population density, time of year, the frequency with which such events occur, lead time before the crisis strikes, and whether the event affected neighboring communities.

The assumption is that disasters will occur. There will always be devastating events that catch us off-guard and overwhelm the resources of churches, families, communities, and economic and governmental systems.

#### Understanding the Disaster Cycle

Disasters are often preceded by anticipatory periods, which are not characterized by clear starting or ending points. After a disaster, those involved tend to go through predictable stages. These stages are best understood as a continual cycle:

- 1. Critical incidents will vary in length and severity.
- 2. Emergency response occurs immediately after a disaster and can last minutes, hours, or days. This stage includes search and rescue, emergency shelters and feeding programs, grief counseling, pastoral care, volunteer services, and reestablishing contact with family and friends.

- 3. Relief starts 12 to 72 hours after a disaster. It is characterized by debris removal and clean up, damage assessments, temporary repairs, applications for assistance, community needs assessment, decisions, and organization for recovery.
- 4. Long-term recovery begins three to five days after a disaster and can last months to years. This stage comprises permanent repairs and rebuilding, bureaucratic complications, volunteer projects, and agency coordination.
- 5. Mitigation and preparedness can help to lessen the severity of the impact of future events, increasing the speed and efficiency of rescue, assessment, and relief.

#### **Recommendations:**

- 1. Each church should consider creating/developing a Congregational Preparedness Plan
  - Creating a plan for congregational preparedness is a gradual and evolving process. It may not
    always be straightforward, but it develops naturally as the church and community explore its
    strengths and commitment to preparedness. The ideal outcome is for each congregation to
    have a thorough plan embraced, taught, and practiced by all members. The tasks below
    represent a suggested model a church community can follow to complete its unique
    preparedness plan.
    - Task #1: Team, Purpose, Vision, and Goals.
    - Task #2: Designate Members for the Response Team.
    - Task #3: Conduct a Disaster Risk Assessment with your insurance company.
    - Task #4: Inventory and document all assets of the church.
    - Task #5: Assess the current vulnerabilities of the plan and look for methods to reduce the identified risks.
    - Task #6: Identify partners, agreements, and other resources. Once they are identified, document them, keeping a copy on and off-site in case of disaster.
    - Task #7: Document your decision-making process. A well-documented decision-making process will ensure no critical time is lost during a disaster.
    - Task #8: Create a communication plan to inform members and church leadership of the status and next steps.
    - Task #9: Identify how the church will continue to operate during the recovery.
    - Task #10: Obtain congregational approval.
    - Task #11: Educate, practice, and review regularly.
